Trustee Election

There is one five-year Trustee position open commencing on July 1, 2025 – June 30, 2030. This position is currently held by incumbent Ronald F. Devine, Jr. whose term expires on June 30, 2025.

Registration

Registration is on-going at the Office of the School District Clerk on any school day between the hours of 9:00 am and 3:00 pm until April 4, 2025.

Qualifications for Voting

Age: 18 and over. Citizen of the U.S. Resident in Bayport-Blue Point School District for at least 30 days. Registered to vote in general or school district elections.

Absentee Ballots

If you are unable to vote in person, you may apply for an absentee ballot at the library during regular hours or at the Office of the School District Clerk on any school day between 9:00 am and 5:00 pm.

The School District Clerk must receive the application at least seven (7) days before the election if the ballot is to be mailed to the voter, or the day before the election if it is to be delivered personally to the voter. The school district clerk must receive absentee ballots not later than 5:00 pm on the day of the vote, Tuesday, April 8.

^{*}This budget will reflect an approximate tax increase for the average home of approximately \$1.50 per month.

BUDGET FAQs:

Will my taxes increase because of this budget? Yes, the tax increase would be about \$1.50 per month (\$18 per year) for the average household.

What are some of the increased costs in this budget? Mandated Government employee health insurance and NYS Retirement System increases; updated pricing for costly shared databases and electronic resources; modest staff salary increases (which are partially offset by staff retirements).

What new initiatives are included in this year's budget? This budget includes increased hours for several existing staff members to help replace the recent retirements.



What happens if the budget is not approved? The Library Board has the option of scheduling a re-voting (the same or an altered budget) or keep last year's approved budget.



What happened or will happen with the proceeds of the sale of the old library? Those net funds will be transferred (as per the public referendum approved in 2023) to an interest bearing account until February 2028, at which time they will be used to pay down and reduce the Bond Debt for our new library.

When and where can I vote on the budget? At the library on April 8, from 9 a.m. until 8 p.m.
